Buy Safe & Keep Safe

We rely on many things we buy to make our lives easier, to help us and support our wellbeing. But not all products you buy new or second-hand may be made well or meet required safety standards that you would expect.

Taking the time to do some simple checks before making a purchase from a shop or online can avoid accidents and injuries to you, your family and friends.

What you should look for Here are some simple things you can do before buying products:

- Does the product have safety markings or warnings?
 Are there any instructions and
- Can you see the address of the manufacturer or seller?
- If you can't see any of these things on the packaging or the item, it may mean that the product you are buying is not safe to use or hasn't been tested by the manufacturer to make sure it meets safety standards.

Buying second-hand


If you're thinking of purchasing something second-hand, consider how old it is and if anything might have happened to it during its lifetime — can you see any obvious damage which could make it unsafe to use?

Register your products

Many household products, especially electrical ones, come with the option to register them with the manufacturer. Registering your product means that you can then be directly informed if there is a safety issue with it and get any repairs done as soon as possible. If it is recalled, a refund or replacement may be available.

Consumer Alerts – June 2024

Driveway scam

Beware cold callers knocking on doors in the Lancaster area offering to spray your driveway to kill weeds and/or power wash your drive. One resident paid £250 and suspects no weed killer was used. Another resident paid £200 upfront as part payment for the job, the traders did not return to carry out the work.

Trading Standards advice is to always say no to cold callers. The Safetrader scheme can help you find a trader in your area, contact 0303 333 1111 or go to www.safetrader.org.uk.

Dating investment scam

A Lancashire resident lost £6,000 after meeting someone on a dating site who claimed to be a stock trader. After a number of conversations, and a future plan to meet, his date convinced the complainant to go into business with her, asking him to take out a loan in his name, which they would pay back together. The money was to be used to invest in stocks to generate additional profit which would then be invested into the business.

However, when it came time to pay the loan back, the scammer vanished with the money. This was a very professional scam, with an untraceable website and a plausible back story. Never send money to someone unrecommended, who you do not know, no matter how good the business opportunity sounds.

Message scam

Be suspicious and use caution if you receive a text or What's App message

from a family member or close friend from a mobile number you do not recognise asking for money. Typically, the message can allege it is from your son or daughter saying this is their new number and the request for money will sound urgent.

Fraudulent Virgin calls

Beware receiving a scam call from Virgin Media. One householder, on answering the phone call, stated they were not with Virgin but the caller managed to convince them they were carrying out improvement/ modernisation work for all internet providing companies. The caller managed to obtain personal information and shortly after tried to obtain money via the internet users Paypal account.

Another similar internet related scam call claims to be checking internet speeds, claiming the speed the user is getting is much less than they are paying for. This then leads to the caller advising they need to connect your hub to the main server and ask you to download an App to your phone, potentially enabling the caller direct access to your computer.

BEWARE OF THE LATEST SCAMS

Dear Debra,

Lancashire Constabulary are committed to keeping the residents of Lancashire up-to-date with the latest frauds that we see being reported to us on a daily basis. We hope that this article helps you avoid becoming a victim to one of them:

EMAIL SCAM



This particular scam email popped into my personal inbox one morning this week, informing me that there'd been a problem with my TV licensing direct debit and to click the link to access the details. It

had the right logos, but being suspicious of everything that comes into my inbox, I forwarded it on to report@phishing.gov.uk.

Unfortunately, that same afternoon I had a conversation with a victim who had gone onto the link and had several accounts hacked. As well as the financial loss, victims suffer a great deal of stress and anxiety having to report it several times and generally dealing with the repercussions from it, which can be traumatic. If in doubt – don't!

AMAZON PRIME SCAM CALL

Thanks to COVID, most of us use Amazon at some point now. This scam call will come from an unrecognised number. When you answer, the fraudster will tell you that your Amazon Prime subscription is increasing in price or is about to expire.



If you say that you want to cancel

your subscription, you'll be put through to another fraudster. They will tell you that you need to download remote access software (typically the app 'AnyDesk'). This is a genuine program that fraudsters sometimes look to exploit as a vehicle for their scams.

Once you've downloaded the program, you'll grant the scammer access to your device - allowing them to steal your personal information or install malware. Always say that you'll phone the organisation direct, who the criminal purports to be from and hang up. Wait for at least 5 minutes before making a call to ensure that the previous call has disconnected.

DATA BREACH



Saga has confirmed that a data breach has exposed some customers' addresses and partial bank card numbers.

Watch out for emails asking you to update your payment details.

BUYING NON-EXISTENT VEHICLES FROM ON-LINE MARKET PLACES

When it comes to making online purchases from small, unknown retailers or via social media, it's important to fully research the company or seller. Can they prove that they own the vehicle?

Check the company's website for spelling and grammatical errors. If you're encouraged to send money by bank transfer rather than paying by credit or debit card, this could be a sign of a scam.

Keep an eye out for common tactics such as time-limited offers and above all, be on your guard against deals that suck you in. **STOP – THINK – CHECK!**
